

**WEST EWELL ANGLING CLUB (WEAC)**

**MEMBER LIABILITY WAIVER AND RELEASE OF LIABILITY**

I agree to assume any and all risk of injury or death. I further understand and agree to assume all responsibility for risk of theft, loss, or damage to my personal property, which may occur at any time arising from my participation in WEAC activity.

I understand and agree that by signing this Waiver and as a condition of participation in WEAC activity that:

1. I acknowledge that I have voluntarily chosen to participate in WEAC activity and I have full knowledge of the risks that the associated activity presents including injury and / or death relating to travel to, participation in, and returning from all WEAC activity. I am aware portions of this activity are not guided or supervised by the WEAC.
2. I hereby release, waive and discharge WEAC, its directors, officers, employees, agents, successors or lessors (the releasees) from all liability to myself or my guest, my personal representatives, all assignees, heirs, and next of kin for any and all loss or damage, and any claim or demands therefore on account of injury and/or death to myself or my guest and/or property damage / loss, now and forever, arising out of or related to participation in WEAC activities or any other related angling activities that may occur.
3. I hereby assume full responsibility for any risk of bodily injury, death or property loss or damage, now and forever, arising out of or related to participation and / or instruction in said activities, whether foreseen or unforeseen. I hereby separately agree to indemnify and save and hold harmless the Releasees from any loss, liability, damage or cost that they may incur, now and forever, arising out of or related to my (or my guests) participation in WEAC activities.
4. I hereby acknowledge that this Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement extends to all acts relating to the club's activity and is intended to be as broad and inclusive as permitted by the UK laws.
5. I acknowledge that WEAC do not provide insurance coverage for club participants for injuries or loss occurring while participating in club activities. Any injury claim must be filed with the members own group insurance. Prior to participation, members should review their own private coverage and understand the coverage and limitations of their personal policy in regard to aforementioned activities. I, the undersigned, have reviewed my personal insurance policies and understand that the WEAC are not responsible for any injury or loss sustained by participants associated with the club's activity.
6. I have carefully read this agreement and fully understand all of its terms and conditions. I understand this is a release of liability, which could legally prevent me from filing a lawsuit or making any other legal claim for damages in the event of loss of property or my death or injury. With this knowledge, I am entering into this agreement fully and voluntarily. I agree that the agreement is binding upon me, my spouse, my heirs, my children (including any guardian adlitem for my children), my assignees, and any other legal representatives.

**By signing this form, you acknowledge that you have read the above Waiver and Release of Liability and fully understand its terms. You affirm that you are voluntarily participating in club activities and further acknowledge you know, understand and appreciate the inherent risks associated with club sports. You assume full responsibility for any and all injuries, losses or damages that may occur to you as a result of the inherent risks associated with the clubs' activities.**
